

What if I am not admitted to the session?

Why is this happening?

I had no idea before why so many students crowd at the door of the dean's office during the test week. But now I understand what is the reason for all these nerves and worries. Still, any student studying, both on a budgetary and on a contract basis, is afraid to fly out of the university. That is why it is important to understand the essence of the problem.

There may be several reasons for this failure:

1. Frequent truancy.

This is exactly the argument that fails many students, since the desire to walk and have fun is simply absorbing. Accordingly, there is simply not enough time for study during the semester.

2. Wrong perception.

Many students live according to school principles, naively believing that the teacher will still give a grade, and will also invite you to the exam. 3. Blat.

Very often, students are sure that the most omnipotent "hairy hand" will help to close all the passes and failures during the semester. However, such student plans are not always destined to be fulfilled, since often teachers turn out to be principled people, and the truant is asked doubly from the truant.

4. Coursework.

As a rule, admission to a session and a specific subject is a pre-completed and "protected" course work. If a student "failed" on the test or simply did not show up because of his own unpreparedness, then the road to the session is definitely closed to him, no matter what actions he takes.

5. A skirmish with the teacher.

Despite the fact that this problem is described in the very last place, in its relevance it can be safely put in the first place. The fact is that often between the student and the teacher, on an intuitive level, negativity arises, which spoils the life of the student. A strict teacher does not just find fault, but also underestimates grades, trying in every way to prick his ward and demonstrate his own superiority.

It is now obvious that such a global problem as non-admission to the session has a number of good reasons. However, this does not mean at all that the stalemate that has arisen can be ignored, because it is not so far away to replenish the ranks of those expelled. So, in any case, it is necessary to act, and the sooner the better.

What should I do?

Perhaps this is the most common question that worries students during the session. Of course, the situation is unpleasant, but it is still too early to consider it a tragedy.
